#### Dean's Message

Favorable comments still are coming in from alumni in California and from other areas who attended last April's alumni meeting and seminar in Monterey and San Francisco. It was the first time in the memory of veteran alumni that the annual meeting of our Dental Alumni Association was held outside St. Louis. The California get together was in the nature of an experiment, but attendance was so gratifying and the reaction to the meeting was so enthusiastic that I'm sure your alumni officers will be planning more such out-of-town meetings in future years.

One beautiful remembrance that all of us will carry away from the San Francisco meeting was the salute to his classmates by Dr. Paul Mowery of the Class of 1958. Paul presided as his class was honored at the alumni banquet on its 25th anniversary of graduation. His reminiscences of his classmates and their years together at the School were warm and touching and often hilarious. It was a precious few moments that will not soon be forgotten.

Another very poignant moment during the banquet came when Dr. Godfrey Schroeder, retiring President of the Alumni Association, expressed his personal love and concern - the same emotions felt by many others there - for our dear friend Don Sheldon. Don was installed in absentia at the banquet as the new President of the association at a time when he was critically ill in St. Louis. A few weeks after our return home from California, Don died after an illness of several months.

Don Sheldon was a big, happygo-lucky, enthusiastic man, who was a joy to be with and to work with. He had served our Alumni Association faithfully and well as Secretary-Treasurer for several years, as Vice President, and finally as President-Elect, when he was stricken with the illness that

proved to be fatal. Our love and deep sympathy go to Dr. Doxey Sheldon, Don's beloved wife and professional colleague. It sounds very trite to say that Don is and will be missed. . . but no truer words ever were said.

Before Don's death, some changes in the administrative structure of the Alumni Association had left two officer vacancies. These were most ably filled by Dr. Clifford G. Neill ('46) of Carbondale, III. who became President-Elect and Dr. Graydon L. Ballard, Jr. ('62) of St. Louis, who became Vice President. The by-laws of the association provide that, in the event the office of President becomes vacant, it will be filled by the Vice President. Upon Don's passing, therefore, Dude Ballard succeeded to the presidency of the Association and will hold that office until the 1984 annual meeting in September of next year. He then will be succeeded in the office by Cliff Neill. Both Dude and Cliff have been active and loyal alumni of the School for many years. We look forward very much to working with them.

With our California trip and alumni get-together still very fresh in our minds, it is time to turn our thoughts ahead to another very attractive educational trip being planned by our Dental Alumni Association. These annual trips, which started four years ago, have become increasingly popular among our alums and their friends. A particularly attractive one has been planned for you in the months ahead. It will be a trip to Ocho Rios, Jamaica, and will take place from February 11-18, at a time when you'll be delighted to get away from winter's blasts at home. The trip is planned to coincide with the annual meeting of the Jamaica Dental Association, a fine professional meeting that annually attracts many American dentists. The JDA meeting will feature a

#### **Don Sheldon Dies**

Alums, faculty, students and many friends suffered a great loss with the death of Don Sheldon, '61, on June 9. Besides being wellknown and loved by classmates and fellow students during his four years of schooling ('57-61), Don's service on the faculty from 1979 to the present made him also known and liked by more recent alumni. He served our Association for several years as Secretary-Treasurer, then as Vice-President, as President-Elect and finally was installed as President in April. He fought his last illness with all his strength, with optimism and good grace, and his installation as President on April 29 indicated his will and the Association's conviction that he would make it. We all grieve that he was overcome.

Don Sheldon was born on May 5, 1934 in Binghamtom, N.Y., attended high school and college in and around Miami, Florida, graduating from the University of Miami in 1956 with a B.A. in Education. After service with the Coast Guard (56-57) he entered dental school, graduating in 1961. He practiced in Miami and in



Lebanon, Missouri, and returned to St. Louis to practice in 1974. Don took graduate training in Endodontics in 1979, and practiced in Frontenac with his wife, Doxey Ransom Sheldon, '79, since then. He leaves his wife, two daughters, a step-son, a stepdaughter and his parents. We shall all miss that great big bear of a guy, and extend our deepest sympathy to his mourning family.

The WU Dental Alumni Association, in a departure from tradition, held its 117th Annual Meeting April 28 and 29 in San Francisco. It is hoped that the meeting will be held, every five years or so, in a different part of the nation.



#### (DEAN'S MESSAGE cont.)

Speaking of dental meetings, just a reminder that our 1984 alumni annual meeting will be held in St. Louis in the Fall of next year, so as to coincide with the annual Mid-Continent Dental Meeting. We hope thus to enable you to enjoy the traditional alumni festivities while also having the benefit of attending a major dental meeting at the same time. The 1984 Mid-Continent dates will be September 28 - October 1. Please note them in your calendar and we'll be sending you a lot more information about

our alumni reunion plans as the months go by.

About the time you're reading this, we'll be welcoming to the School another incoming class of freshman dental students, the men and women who will make up our Class of 1987. These intelligent, hard-working young people were carefully chosen by our Admissions Committee from a field of 1,000 applicants. Our total number of applications declined a bit from the previous year, a continuation of a decline in applications that has lasted for several years and has affected virtually every dental school. As you know, we are conducting a vigorous national recruitment program to bring the best qualified students to our School and in sufficient numbers. This program is working well; without it, our decline in applications would have been far more serious.

A critical factor in our recruitment of students is the availability of financial aid. The improvement of our financial aid resources for students is a key goal of our participation in the ALLIANCE FOR WASHINGTON UNIVERSITY. I know you will support this campaign generously when you are called upon. If our goals are attained, I know we can look forward to two decades of steady progress.

Speaking of financial aid, that outlook was brightened by the additional generosity of the widow of one of our alumni. Mrs. Jeannette Musgrave of Springfield, Mo. gave another \$50,000 to the Dr. Edward F. Musgrave Student Loan Fund in memory of her husband. Such gifts are immeasurably helpful in reducing the frightening financial burdens borne by our students.

A real bright spot of our San Francisco meeting was the announcement by the assembled members of the Class of '58 that their class — to mark its 25th anniversary of graduation — had pledged a class gift of \$10,500 to the School. This may be the largest such class gift ever received by our School. It was an incredible gesture of support and loyalty by this class and was extremely gratifying to us all.

In my last message to you, I told of some administrative changes linked to the continuing reemphasis on basic science and clinical research at our School. A part of this revitalization has been the fostering of close research ties with other divisions of Washington U. and with other institutions. These relationships have led to two major additions to our research faculty: Dr. Roy Curtiss, III, Professor and Chairman of the WU Department of Biology, has accepted a joint appointment with us as Professor of Cellular and Molecular Biology. And Dr. George Wilner, Director of Laboratory Medicine at Jewish Hospital of St. Louis, has a joint appointment with us as Research Associate Professor in Cell Biology and Biochemistry. The addition of such outstanding scientists to our faculty is just one more indication of our burgeoning research activity.

Many alumni of the School joined faculty and staff members and their spouses in attendance at a dinner marking the retirement of our dear friend Dr. John R. Ring after 36 years of faithful service to the School. Bob Ring filled many important positions as teacher and administrator and he played a key role in saving the School during its time of great crisis in the late 1960s. No one can replace him, but he is ably succeeded in two of his major posts by Dr. Richard Brand as Director of Admissions and by Dr. Charles Waldron as head of the Office of Student Services. With Bob Ring go our heartfelt best wishes for a happy and healthy retirement.

#### Jamaica - 1984 Alumni C.E. Trip

The warm, garden-like northern coast of Jamaica will be the magnet for Washington U. dental alumni this winter as the Dental Alumni Association sponsors its annual continuing education trip for alumni, their spouses, children, and friends.

The week-long escape from the rigors of the U.S. winter will take place on February 11-18, 1984. The destination will be Ocho Rios, a lovely resort area on the ocean and backed by lush green mountains. The professional attraction will be the annual meeting of the Jamaica Dental Association, featuring outstanding clinical sessions.

Headquarters for the WU dental alumni in Ocho Rios will be the plush Americana Ocho Rios Hotel, which boasts colorful quest rooms with private balconies overlooking the mountains and the sea, outstanding restaurants, and such other amenities as a big private beach, a beautiful pool, a lighted tennis complex, a golf course nearby, and its own shopping arcade. The Jamaica Dental Association meeting will take place right next door, at the Sheraton Ocho Rios.

Because Jamaica is such a popular winter travel destination. hotel and air reservations are at a premium. This has forced the travel agency handling this trip to set a very early deadline for making reservations. To insure your participation in the Jamaica trip, your reservation and deposit must be in the travel agency's

hands by no later than October 11. professional education or meetings All dental alumni are urged to make their reservations promptly in order to avoid disappointment.

Travel arrangements for the Jamaica alumni trip are being made by Altair International Travel of St. Louis, which has supervised other successful WU alumni trips. Altair has arranged economical charter air transportation between St. Louis and Jamaica, but also will arrange alternative air plans for those who find it inconvenient to start their trips from St. Louis. An Altair representative will escort the trip.

The JDA meeting (February 12-16) has been an attraction for U.S. dentists for many years. The 1984 session will feature five hours of clinical programs on each of three days. Dr. Ronald Jordan, the widely-known Canadian authority, will give a two-day program on restorative dentistry, and there also will be sessions on crown & bridge and oral-maxillofacial surgery, among others. Social events connected to the meeting will include a Rum Punch icebreaker party and a Jamaica Night, featuring entertainment and dinner. The auxiliary of the JDA is arranging tours and shopping for spouses of dentists during the hours when clinical sessions are scheduled. The registration fee for the JDA meeting will be \$120.00 in U.S. dollars.

### **Annual Fund** Report

The Annual Fund figures for the last fiscal year are complete and the Dental School is pleased to report that 769 or 33.5 percent of its 2,293 alumni gave \$130,254, and 115 friends of the School donated \$24,696 for a total contribution of \$154,950 to the Annual Fund.

This compares to 805 or 36 percent of 2,238 alumni who gave \$122,040 and 145 friends who gave \$30,386 for a total of \$152,426 for the same time period a year ago.

While the percentage of participation is down, the total amount of dollars received has increased slightly. Giving fell short of the \$161,000 goal by \$6,050 partly because \$15,872 of the \$53,241 pledged during phonathons was not received.

There is good news in the Giving Club area. The Eliot Society has 41 paid members including eight new members: Dr. Samuel R. Maehara, Dr. & Mrs. Henry R. Dallam, Dr. & Mrs. W. Neal Newton, Dr. & Mrs. Larson Keso, Dr. & Mrs. Stuart C. Stanhope, Dr. Frank B. Allen, Dr. & Mrs. Vernon R. Debus and Dr. & Mrs. Henry E. Dupree

There are 445 members in the Century Club, compared to 435 a year ago; 135 members in the Boling Associates compared to 114 a year ago; and 42 members of the Dean's Committee compared to 37 a year ago.

Alumni participation in support of the School's programs is extremely important in these days when private schools are particularly hard pressed by rising costs. The Annual Fund is a meaningful way alumni can help make it possible for their School to maintain high academic standards. No school can do it alone.

The School of Dental Medicine deeply appreciates the loyalty and support of all its alumni who worked so hard on behalf of last year's Annual Fund including Dr. Leo S. Shanley who served as Annual Fund Chairman; Dr. В. French Warren spearheaded the Eliot Society Membership Committee; Dr. Earl E. Shepard who chaired the School's Planned Giving Committee, and Dr. Gordon C. Century Club Thompson. President, who was responsible for the phonathon efforts this past year. The School is enriched by their commitment of time and interest.

## Gilster Leads ALLIANCE

The appointment of Dr. John E. Gilster to serve as Annual Programs Chairman for the School of Dental Medicine in the ALLIANCE FOR WASHINGTON UNIVER-SITY, a program to raise \$300 million in gift support has been announced by George H. Capps, General Chairman. The ALLIANCE is the largest on record in the University's history and one of the largest in the history of higher education.

The ALLIANCE was created in response to the report of the Commission on the Future of Washington University. Its purpose is to enable the University to fulfill its educational plans for the final years of this century in a vigorous and wise manner.

The Dental School has set as its priorities \$400,000 to endow student loan funds and \$600,000 to develop a new library and learning resources center. In addition, the School is seekin' \$1.4 million in new and increased gifts in support of annual programs from its alumni and friends.

Unrestricted annual gifts, a major source of income to the School as it meets its day-to-day operating expenses, are used for such essentials as student aid, faculty compensation and research and library support. To meet these needs, the School will require unrestricted gifts averaging \$200,000 a year over the next four years in addition to operating funds which have already been raised.
